## Information

The Development Services Division offers written verification of zoning, zoning history, or other zoning related matters as a paid service. Please allow 21 days to process your request following payment. Letters are issued in the order in which they are requested. Expedited services for special requests are offered subject to staff availability. Expedited letters are issued within 7 days after payment of fees.

## Services offered

**CDMP Future Land Use Plan Map Designation** Provides the land use designation as depicted on the Miami-Dade County Comprehensive Development Master Plan (CDMP) Future Land Use Plan Map; no interpretation of the plan designation will be given. **\$118.35**

**Zoning History Research** Provides confirmation of the Zoning District and the zoning history which includes copies of zoning resolutions, administrative approvals, agreements and covenants (if available). Request this service if only the zoning information and resolution history of the property is needed. **\$236.67**

**Special Request not concerning a specific parcel** Zoning code interpretation, permitted use questions or written confirmation/information on other zoning matters. **\$473.34**, Expedited **\$946.69**

**Florida Housing Finance Corporation** Project letters and completion of FHFC application forms. **\$236.67**

**Zoning History Research and Analysis** Zoning analysis of a zoning related matter or zoning code question concerning a specific parcel provides a response to specific zoning matter or question related to the zoning approvals of a parcel, a code interpretation or a proposed use of a site. Note: this service includes zoning history research as described above. Please include a letter of intent and explanation of the proposed use or other zoning matter to be addressed. **\$473.34**, Expedited **\$946.69**

**Verification of Pedestrian-Oriented Development (POD)** Determinations for road impact fee reduction purposes pursuant to Section 33E-8. Provides verification that the parcel lies within the approved POD development in accordance with the requirements of Miami-Dade County Ordinance 16-132. Applicant must provide POD approval or parcel identification number and a copy of building permit plans. **\$236.67**.

## Submittal Requirements

This application must be complete and accompanied by the required fee as indicated. Fees may be paid with credit card or check payable to Miami-Dade County. Fees are non-refundable. Multiple address or parcels/folios must be submitted as separate requests except where all parcels/folios are contiguous and the subject of a single zoning action.
